DIRECT CREMATION

Direct Cremation.....: refer to map \$695 to \$1,295

Our fee for a direct cremation (without ceremony) includes: the cremation and processing fee; basic services of funeral director & staff; removal of remains to our cremation provider, filing of required documents and authorizations. Dignified arrangements will be conducted in person or by phone and e-mail during business hours. **These items are marked with a * in the itemization portion of this price list. All other services requested would be additional.**

If you want to arrange a direct cremation, you can use an alternative container. Alternative cremation containers encase the body and may be made of materials like unfinished wood, fiberboard, composition materials, pressed-wood or other similar non-metal materials (with or without an outside covering). The container we provide is a heavy cardboard box.

1. With container provided by the purchaser....refer to map: \$695 to \$1,295

2. With cardboard alternative container.....

refer to map: \$880 to \$1,480

NOTE: Additional charges may be required and vary due to circumstances at the time of death. Examples would be obesity charges, a 2nd person required on the removal from location of death and pacemaker removal.

PROFESSIONAL SERVICES

Basic Services of Funeral Director & Staff and Overhead.....\$145

Our basic services fee includes, but is not limited to: the services of our funeral directors and staff to respond to the initial request for service in relation to the geographical area where the death occurred; In addition, this fee includes a proportionate share of overhead expenses relative to operating our facilities, such as an answering service to respond 24 hours a day to calls; accounting and billing, administrative and secretarial costs; insurance and legal expenses, governmental compliance; maintenance and utility expenses, equipment and inventory expenses and similar overhead expenses necessary to operate The Cremation Society of Iowa. This fee is non-declinable.

• Transfer of Remains to the Funeral Home and cremation.....\$550 - \$1150

The removal of the deceased from the location of death by a Funeral Director, and the charge for the cremation process.

• Alternative container and storage.....\$185 *

• Urns.....\$0 - \$2,910

If you do not select an urn, the cremated remains will be returned in a minimal cardboard container.

• Home Removal or additional person required (Per Person).....\$95
